FORMAL WEATHER NET PREAMBLE FOR DEKALB EOC

Calling all radio amateurs. This is **<your call or KB4EMA>** at **<your location or the DeKalb County Emergency Operations Center>**. My name is **<<u>your name</u>>**.

At this time we are opening a formal session of the DeKalb County Weather Net in response to severe weather in the DeKalb County area. This net provides support to local government agencies and the National Weather Service. All participation is appreciated. This is a formal, directed net and all traffic should be directed to net control, <your call or KB4EMA>. Normal amateur use of this repeater is suspended for the duration. Stations with emergency traffic should break in at any time.

IF THERE WAS A PRELIMINARY INFORMAL NET

We will be taking check-ins shortly, beginning with a roll call of stations checked in to any informal session of this net. Stations not yet checked in should do so following the roll call by giving their callsign, name, and location.

IF THERE WAS NO PRELIMINARY INFORMAL NET

We will be taking check-ins shortly.

If you are mobile, please say so. We will be asking for an alternate net control station in the event that I cannot continue as primary net control station. We will also ask for liaison stations with the North Alabama Southern Middle Tennessee SKYWARN Emergency Net on **<insert repeater frequency>** MHz, and the Alabama Traffic Net Mike on 3.965 MHz. Please stand by.

All stations should monitor this frequency and stand by during the net except to:

- check in and out;
- respond to queries from the net; or
- report <u>significant</u> events.

Significant events typically include <u>personal</u> observations of:

- Tornado:
- Funnel cloud;
- Wall cloud;
- Pea-size hail (or larger);
- Rainfall rates in excess of 1 inch per hour;
- Wind speeds in excess of 50 mph;
- Structure damage; and
- Injuries.

If sightings of tornadoes or funnel clouds are reported, other stations should hold reports of less threatening events for a break in action. All reports will be relayed to the National Weather Service and/or local government agencies, as appropriate.

Net participants should exercise good judgment when participating in severe weather-related activities. Your safety is a critical concern. You should always make safety your first priority before, during and after any activities related to net operations. Seek shelter when appropriate and provide reports to the net only when it is safe to do so.

In the event that this repeater fails, the Rainsville repeater (147.47 MHz; minus 600 KHz offset; 77 Hz tone) is the designated backup frequency. The secondary backup frequency is 147.27 MHz simplex with 100 Hz tone should conditions make both repeaters unusable. If the net control station is unable to direct the net we will need an alternate net

control station. Any station wishing to act as alternate net control please call now.... <pause>

OPTIONAL

We also need to designate a liaison station with the Alabama Traffic Net Mike on 3.965 MHz. If you have 75m SSB capability and would like to serve as a liaison station to this net, please call now<

<Under some circumstances we may need to establish liaison stations with D-Star nets, other neighboring counties' nets, local area shelter nets, etc. If this is the case, other liaison stations can be solicited at this point. >
